For and in consideration of the participation of the undersigned (the "Participant") in Kids Hip-Hop, Adult Dance, Special Events, and any and all other related activities (collectively, the "Activities"), Participant hereby indemnifies, releases from liability and holds harmless Dance on the DL, LLC, their respective members, managers, employees, contractors, affiliated companies and individuals, principals, subordinates, officers, directors, representatives, guests and invitees (collectively, the "Released Parties") from all loss, costs and/or damages due to accident, injury, illness, death to person(s) and/or property, or other consequences suffered or incurred by Participant or any other person resulting directly or indirectly from Participant's participation in any of the Activities or use of the facilities, parking areas or services related to any of the Activities, whether foreseen or unforeseen, known or unknown, now and forever.

PARTICIPANT IS AWARE OF THE POTENTIAL DANGERS INHERENT IN ENGAGING IN ANY OF THE ACTIVITIES, AND THAT THIS IS A WAIVER AND GENERAL RELEASE OF ALL LIABILITY. PARTICIPANT EXPRESSLY ASSUMES ALL RISK TO HIM/HERSELF AND/OR OTHERS, AND SHALL BE SOLELY RESPONSIBLE FOR ALL LOSS, COSTS AND DAMAGES RELATED TO PARTICIPATION IN THE ACTIVITIES (OR ANY OF THEM), INCLUDING, WITHOUT LIMITATION, INCIDENTAL AND CONSEQUENTIAL DAMAGES.
